On behalf of the residents of DBM, thank you to everyone who helped make the 2026 tournament a great

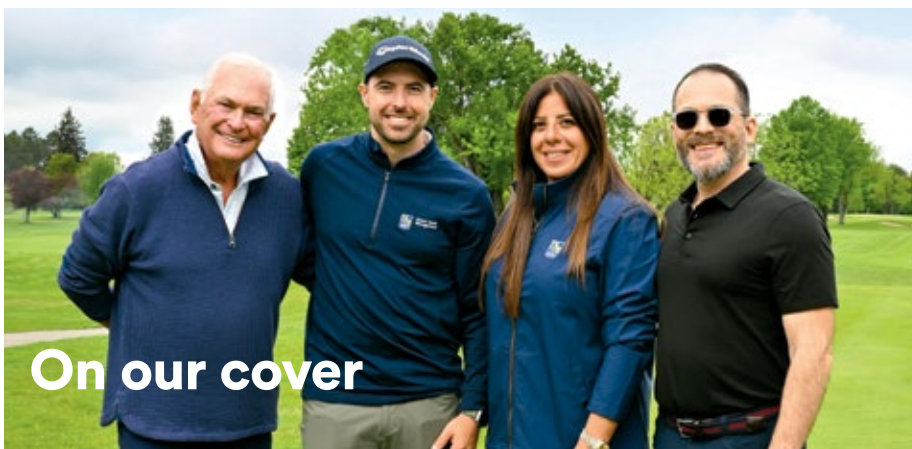

## The future is here: AI Pilot Project Enhances Resident Care at DBJ

A pilot project on the fourth floor of the Kastner pavilion at Donald Berman Jewish Eldercare is using AI technology to improve resident care.

The technology, developed by AMBA, continuously monitors the residents' heart-rate, breathing, sleep patterns and activity levels. AMBA collects the information from discreet devices placed around a resident's room. These devices include a sleep mat, motion sensors, and door sensors that send real-time health and well-being data to the caregivers' dashboard. This allows the nursing team to be alerted to important changes in the residents' routine or pattern through an immediate phone call or alert on a dedicated cell-phone. It is all done discreetly without wearables, cameras or microphones.

"AI technology doesn't replace human care," says Jennifer Clarke, Director of SAPA, adding. "It supports the staff and gives them additional tools to be more efficient and to provide personalized care."

For example, if a resident falls, staff is notified immediately and can respond within those first critical moments, rather than relying on a scheduled room check to discover an accident.

Beyond urgent situations, care teams are also able to provide more proactive and personalized care as the AMBA system identifies early signs of health deterioration. As well, by continuously monitoring vital signs, the system can often eliminate the need to wake residents during the night, resulting in better sleep and quality of life.

The AMBA "smart room" project is funded by Donald Berman Jewish Eldercare Foundation, with support from OROT – the "Connected Health

Innovation Incubator" of Santé Québec West-Central Montreal Health and Social Services University Network. Funding sources also include *envisAGE*, a federal and provincial initiative supported by MEDTEQ+ and AGE-WELL.

The current pilot project at DBJ is 32 resident rooms. Formal data analysis is ongoing. If it is proven to be successful, the system will be expanded to other floors at DBJ as well as DBM.

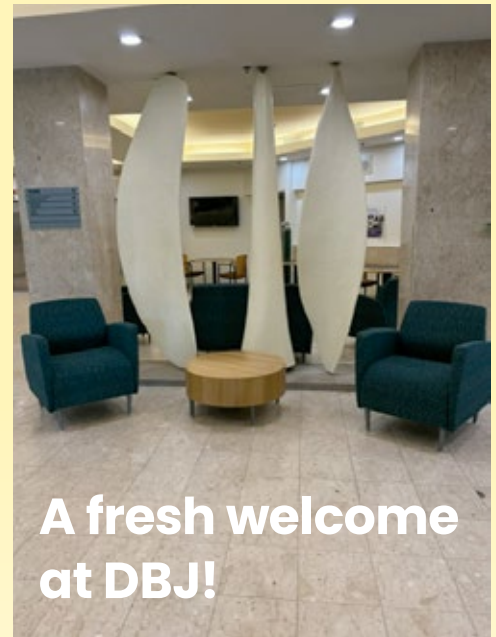

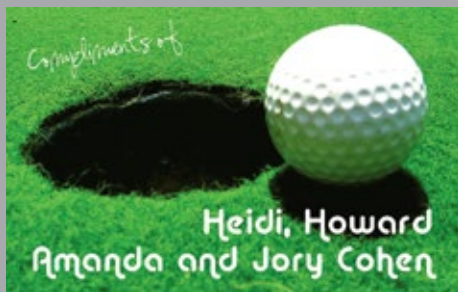

## A visit to The Hogeweyk



fulfilling way of life. Spread across four acres, the village is home to around 150 residents, all of whom are living with moderate to severe dementia. Hogeweyk isn't a care institution; it feels like a real neighbourhood, complete with houses, a theatre, shops, cafés, a restaurant, a post office, and green spaces.

This kind of dementia village is a specially designed care facility built to look, feel and function like a small town. Instead of living in a traditional nursing home setting, residents can move around freely and safely, supported by discreet care staff trained to blend into the village environment. For example, a caregiver may take on the role of a shop assistant, neighbour or barista, encouraging active participation in daily life while ensuring each person receives the required care. "It was an incredible experience. We may not be able to create a full village, but there are elements that can be incorporated into the care we provide here," says Clarke.

Foundation Director Karen Flam and Jennifer Clarke, Director of the Support Program for the Autonomy of Seniors (SAPA) for Santé Québec West-Central Montreal, recently went to Amsterdam to visit the "Amsterdam Dementia Village," known as The Hogeweyk. It's a groundbreaking care model that offers people living with dementia a more independent,

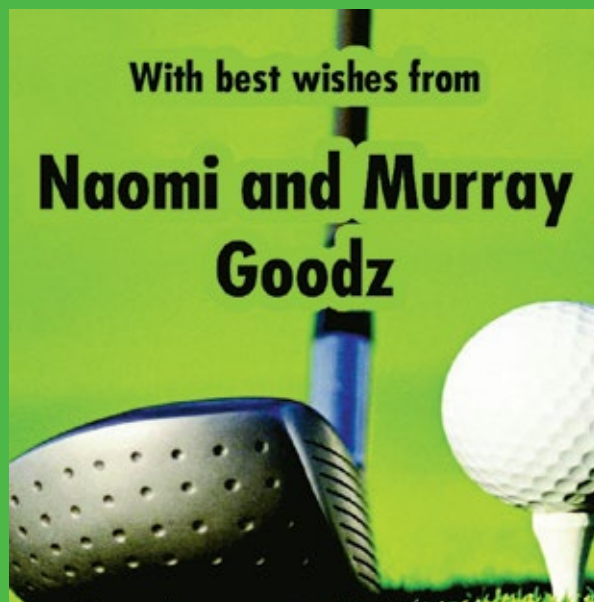

# Beyond the Floor: A New Model of Resident- Centred Care

A new approach to care is taking shape at Donald Berman Maimonides and Donald Berman Jewish Eldercare—one that puts the resident, rather than their level of care, at the centre.

Traditionally, residents were grouped by their stage of illness or level of care, with designated floors serving specific populations. Care and activities were tailored to residents based on each floor's mandate. When a resident's needs changed, a move to another floor could be necessary.

That model is changing.

Through a **micro-milieu approach**, residents with different abilities, diagnoses and stages of illness live together throughout the building as part of one connected community. Rather than organizing the building around levels of care, the focus is on creating an environment where residents can remain in a familiar setting while their care adapts around them.

"Our resident profile has changed so much since COVID that the floor-mandate system no longer works," says Hetal Patel, Assistant to the Director of SAPA. "We need to adapt to our changing clientele."

The approach also recognizes the value residents can bring to one another. Mixed-community living creates opportunities for meaningful connections among people with different interests, abilities and experiences. At the same time, residents with more advanced needs remain active members of the community rather than becoming separated from it.

The new model also eliminates the need for residents to transfer between floors when their care needs change. Residents can remain in the rooms and environments they know, surrounded by familiar staff and other residents, while the care team adapts to their changing needs.

It is an approach rooted in **value-based health care** — one that considers not only the medical needs of the resident, but also their quality of life, relationships, independence, dignity and sense of belonging.

"There is more and more research that points to this as the best model for long-term care," says Guillaume Deschenes, Assistant Manager to the Director of SAPA. "We recognize that it is an adjustment in the way of thinking for staff and families. But this is the way of the future, and it is ultimately about doing what is best for our residents."

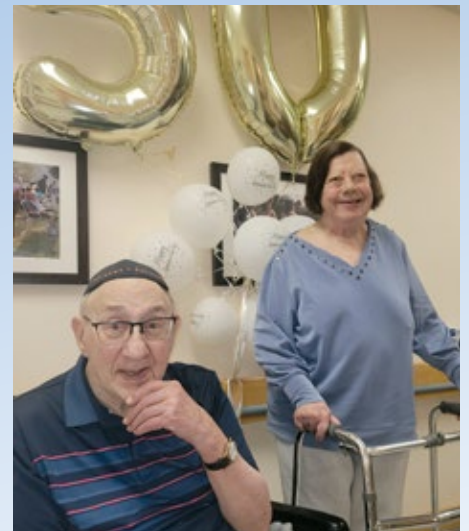
